Dear KSKJ Life Members,

When KSKJ Life was formed in 1894, our founders adopted the motto “All for Faith, Home and Country.” The design of KSKJ as a fraternal benefit society was to aid members by fostering friendship, inspiring religious compliance and civic duties, as well as cherishing with pride the native language and national origin of our members. Membership was easy to come by with the many immigrants flocking to join to be a part of the only game in town for the new arrivals in America. Fraternalism was provided through the lodge and was a very important part of KSKJ. As time went by, new lodges were formed geographically based on the location of mines and mills where they migrated for work. As the lodge system became stronger and membership grew, selection of members became a more sophisticated process. Automatic admission to the lodge was not guaranteed. Often there were more wanting to join than were accepted for membership. The lodge officers and leaders were in complete control of the membership of KSKJ. These were the early days of our society and the KSKJ of our founders and grandparents.

Over time, historical world events and societal movements created meaningful and challenging changes in our lodge system. Mines shut down, factories closed, and many cities where we had strong lodges no longer provided adequate jobs. When the work moved, the ability to make a decent living went away. To find a future, it meant moving somewhere else. Younger generations were also getting better educated and moving to find career opportunities. As a result, the impact to many of our lodges was devastating. Mergers and dissolutions were common and significantly impacted the way we were able to provide fraternal services to members. Currently we have about a tenth of the lodges that we once had. Fortunately, we have several strong and formidable lodges serving in some of our traditional member locations.

Today our KSKJ Life membership is expanded all over America. Allegiance to a single employer or to a home town community is the exception rather than the rule. As a result, many of our members have limited or no association with their lodge. Although we are very committed to our lodge system, we have been consciously working to provide opportunities outside that structure, adapting to the trends of our membership. Our Educational Grant benefit is a key initiative that we have made available for all qualifying members. Scholarships used to be tied to the lodge system and competitively allocated. Also, we have expanded our Matching Funds program. Lodges, as well as a member outside the lodge, can initiate a qualifying Matching Funds event. This is one of our most successful community services. In addition to our ScriptSave benefit, in recent years we have also added purchasing discount programs in PerkSpot and American Hearing Benefits. As we continue to expand these types of fraternal amenities for our members, we will be utilizing the newly approved Fraternal Committee to identify and suggest many of these services. Our commitment to our members has not changed from the original reason KSKJ was formed, only the way we go about getting them to you continues to evolve. KSKJ Life is dedicated to promoting friendship for our members, making a difference in our communities, and being there for you when you need us.

FRATERNAL SNAPSHOT



over **\$2.7M**

In collaboration with other non-profit groups, over \$2.7 million has been donated to benefit charitable organizations, churches and schools since the inception of the Matching Funds Program in 1994. Of this amount, **over \$40,000** was donated by KSKJ Life in 2016 alone through our **Matching Funds and Charitable Giving Awards.**

Since the introduction of the Educational Grant Program in 2015, **\$384,375** in educational grants and scholarships have been awarded, of which **\$51,000** was disbursed for the 2017-2018 school year.



Over 80,000 volunteer hours have been contributed by our members since 2010. Total number of hours in 2016 amounted to **4,661.**

A COMMITMENT TO VOLUNTEERISM AND SERVICE

Since 2010, our members have contributed over 80,000 volunteer hours—whether that be from participating in a Matching Funds event with their local lodge or in a community-wide day of service. Each year, KSKJ Life recognizes two individuals who demonstrate an exceptional commitment to our mission of volunteerism and service.

NATIONAL LODGE PERSON OF THE YEAR
